### **Personal data we process**

Nedupack Thermoforming B.V. processes your personal data because you make use of our services and/or because you provide them to us yourself.

### **Special and/or sensitive personal data we process**

Our website and/or service does not intend to collect data relating to website visitors who are younger than 16 years, unless they have permission from parents or guardian. ### **For which purpose and on which basis do we process data**

Nedupack Thermoforming B.V. processes your personal data for the following purposes:

- The processing of your payment

- To be able to contact you by telephone or e-mail if this necessary to be able to carry out our service
- To inform you about changes in our services and products
- To deliver goods and services to you
- Nedupack Thermoforming B.V. analyses your behaviour on the website in order to improve the website and tailor the offer of products and services to your preferences.
- Nedupack Thermoforming B.V. also processes personal data if we are legally obliged to do so, such as the data we require for our tax return.

### **Automated decision-making**

Nedupack Thermoforming B.V. does not make decisions on the basis of automated processing on matters that could have (substantial) consequences for individuals. This relates to decisions made by computer software or systems without human involvement (an employee of Nedupack Thermoforming B.V., for example).

### **How long we keep personal data**

Nedupack Thermoforming B.V. keeps your personal data for no longer than is strictly necessary to realise the purposes for which your data is collected.

### **Sharing personal data with third parties**

Nedupack Thermoforming B.V. does not sell your data to third parties and only provides this if this is required for the performance of our agreement with you or to comply with a statutory obligation. With companies that process your data on our instruction we enter into a processor's agreement to safeguard the same level of security and confidentiality of your data. Nedupack Thermoforming B.V. remains responsible for this processing.

### **Cookies, or comparable techniques, we use**

Nedupack Thermoforming B.V. uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone during your first visit to this website. Nedupack Thermoforming B.V. uses cookies with a purely technical functionality. These cookies ensure that the website operates properly and that your preferential settings are remembered, for example. They are also used to be able to optimise the website.
